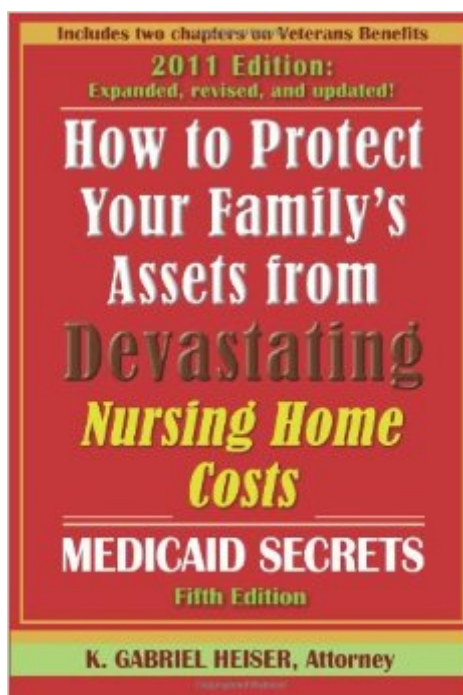

Excellent book you've written, Mr. Heiser. Everyone over 50, everyone with aging parents, and every professional who advises aging people on legal or financial matters should read this book as a primer on this topic, which eventually affects almost anyone who lives long enough. It is possible, I

suppose, to find a fair amount of this information in bits and pieces scattered far and wide over the internet, but it would take days of research to do it, and the sources would largely be unverified. Your book brings it all together in one place, presents it in plain English and in context, and provides updates and access to the author--all for less than the cost of a dinner for two at the local steakhouse. What a bargain.

I believe this book is the best that it can be, given that it does not purport to cover rules unique to each area of the US. I found it very useful. However, I thought I was ordering the latest version (Kindle), and instead received the download of an older version.

Given the increasing costs of medical care and shrinking entitlements, this book is a must have for all of us whose aging parents and relatives will come to depend on good advice such as related in this handy reference work. There is just enough information to encourage the reader to seek an attorney or adviser with whom they can work to insure future benefits. I'd recommend this to anyone in need of this information.
